## Program Action Plan (PAP) Update for period April – June 2022

This note provides a status on the procurement implementation activities undertaken by States/Union Territories (UTs) for the STRIVE Program. This quarterly update captures summary of cumulative data reported by downstream implementing agencies (States, ITIs, and ICs) for period Q1 FY 2022-23 i.e., April 2022 – June 2022. One of the key highlights of the report is that the implementing agencies have achieved the stated target of 60% in Year 4, as per Annex 8 of the Project Appraisal Document (PAD) of STRIVE. The achievement of PAP is being measured across PAP 1 and PAP 2. PAP 1 is further categorized into reporting from States and ITIs. The achievement status for period April 2022 – June 2022 is summarized below:
