Subject: Release of Grant-in-Aid to the State of **Assam** under the Centrally Sponsored Scheme **'Enhancing Skill Development infrastructure in NE States and Sikkim'**.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 346.68 Lakh (Rupees Three Crore Forty Six Lakh and Sixty Eight Thousand only)** towards 1<sup>st</sup> installment for establishment of new ITI at Rangapara, Sonitpur District to the society "**Assam Skill Development Initiative Society**" in the State of **Assam** under the Scheme "**Enhancing Skill Development infrastructure in NE States and Sikkim**" as detailed below:-

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of Rs. 346.68 Lakh (Rs. Three Crore Forty Six Lakh and Sixty Eight Thousand only) grant-in-aid for creation of capital assets to "**Assam Skill Development Initiative Society**" under the State Government of Assam is subject to the following terms and conditions:

- i. The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- ii. Utilisation Certificate issued to DGT in form GFR-19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilisation.
- iii. Utilisation certificate should be furnished by the State Government of Assam.
- iv. The Sanction is valid upto one year from the date of issue.
- v. All the purchases will be made in accordance with the State Govt. norms.
- vi. Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The "**Assam Skill Development Initiative Society**" is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The expenditure is debit-able to the Major Heads 2230.03.102.15.05.35- Grants for creation of capital assets.

6. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dated 1.4.2010.

7. Section Officer (Cash Section)/ Drawing and Disbursing Officer, DGT, Ministry of Skill Development and Entrepreneurship will draw the amount sanctioned vide para 1 above for Rs.346.68 Lakh and pay Rs.346.68 Lakh to the below mentioned society by transferring electronically to the bank account of the society. The details of the society are given below:

8. As this is the 1<sup>st</sup> installment to the society "**Assam Skill Development Initiative Society**" for establishment of new ITI at Rangapara, Sonitpur District in Assam, hence the question of UC does not arise.

9. Competent Authority has approved the proposal for the relaxation of expenditure ceiling of 33% in the last quarter and 15% in the last month of the FY 2016-17 for the scheme "Enhancing Skill Development Infrastructure in NE States & Sikkim" and notified the same vide MoF (Budget Division)'s ID No.14(11)B(PD)/2016 Dated 28.03.2017.

10. This issues in exercise of the delegated powers and in concurrence with the Integrated Finance Division, Ministry of Skill Development & Entrepreneurship vide AS&FA Dy. No.123 dated 24<sup>th</sup> March, 2017.
