Subject: Release of Grant-in-Aid to the State of Nagaland under the Centrally Sponsored Scheme **'Enhancing Skill Development infrastructure in NE States and Sikkim'** merged under the scheme "Skill Development Mission".

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 310.50 Lakh (Rupees Three Crore Ten Lakh and Fifty Thousand only)** as 1st installment for establishment of 1 new ITI at Peren in the State of Nagaland under Centrally Sponsored Scheme **"Enhancing Skill Development infrastructure in NE States and Sikkim"** merged under the scheme "Skill Development Mission" as detailed below:-

2. Further the above sanction is subjected to the following conditions:

- The Sanction is valid upto one year from the date of issue.
- All the purchases will be made in accordance with the State Govt. norms.
- Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- Subsequent release of funds will be made after sufficient utilization of fund and sending Utilization Certificate as per GFR subject to availability of fund.

3. The Society is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.
4. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24(35)/PF-II/2012 dt29-08-2014.
5. The expenditure is debit-able to the Major Head 3601-Grants in Aid to State Government, 04-Grants for Centrally Sponsored Plan Schemes, 321- Training Grants- Training of Craftsmen and Supervisors, 03 – Others Schemes, 07- Skill Development Initiative/Skill Development (Merged), 35- Grant-in-aid for creation of capital assets.
6. The amount of **Rs. 310.50 Lakh (Rupees Three Crore Ten Lakh and Fifty Thousand only)** may be transferred to Government of Nagaland through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) dated 22-02-1977.
7. This is 1st installment for establishment of 1 new ITI at Peren in the State of Nagaland under the scheme "Enhancing Skill Development Infrastructure in NE States & Sikkim" merged under the scheme "Skill Development Mission", hence the question of UC does not arise.
8. The Government of Nagaland may kindly transfer the same amount to the following bank account of 'Vocational Training Projects Implementation Society of Nagaland', formed for implementation of the scheme in the State of Nagaland as per the following table:
