 - For one District, One ITI and two SDCs will be established.
 - No subsequent release of fund will be made as this is final instalment.
 - · Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).
- 3. The State of Orissa is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation manual.
- 4. The sanction relates to the Plan expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-11/2001 dt. 01.04.2010.
- 5. The expenditure is debit-able to the Major Head 3601- Grants in Aid to State Governments, 04-Grants for Centrally Sponsored Plan Schemes, 321-Training Grants- Training of Craftsmen and Supervisors, 03- Other schemes, 07- Skill Development Mission, 35-Grants for creation of capital assets.

- 6. The amount of Rs. 361.86 Lakh (Rupees Three Crore Sixty One Lakh and Eighty Six Thousand only) may be transferred to Government of Orissa through Reserve Bank of India as per procedure laid down by ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22-02-1977.
