Subject : Admission criteria for Two year IBM Advanced Diploma Course in “IT, Networking & Cloud Computing” - reg

Sir/ Madam,

As you are aware that a Two year ‘ **Advanced Diploma Course in IT, Networking & Cloud Computing**’ is being run in NSTI-s- Bengaluru, Hyderabad, Mumbai, Kolkata & Panipat, as approved by the 2nd Meeting of Committee on ‘Norms & Courses’ held on 14.02.2019. The Assessment/ Exam Guidelines for the same have already been issued vide Letter of even No. dated 07.05.2019.

2. Now, as decided by IBM that this diploma course has to be extended to 40 Institutes (NSTIs + ITIs) to train about 800 students, covering 13 states, for the next academic session, tentatively to begin in Aug/Sept, 2019. Affiliation will be given based form to be uploaded in the website.

3. Admission on NSTIs

- i. The admission to the Advanced Diploma course at NSTIs will be done through an All India Common ONLINE entrance examination to be conducted by DGT.
- ii. The age limit for the admission to this course will be minimum 17 years as on 1st Sept 2019.
- iii. Min. Qualification – X/XII Std + NTC (Any Trade) of 1-year or 2-year course pass with minimum 60% marks/First Class or XII Std pass with minimum 60%/First Class.

- iv. For the Entrance Exam, 80% of the questions to be on logical reasoning, analytical, general knowledge, English comprehension etc. and 20% will be related to computers/IT.
- v. The session for all Institutes will be initiated at the same time, most likely in August/Sept, 2019.
- vi. Option to choose the examination center/ institute will be provided on the portal.

4. Any shortfall in admission thereafter can be filled on the spot by NSTIs directly concerned (only those who have undergone the entrance exam).

5. State Govt ITI's and Private ITI's (with grading of 2.5 and above) interested in starting this IBM Diploma are also permitted subject to the fulfilling the infrastructure and faculty requirement. It is up to the ITI's to decide regarding how to fill-up the seats.

6. Course Fee

- Already an office order F.No.MSDE-D-11028/11(1)/2019-(CFI) dated 4th June,2019 issued for the revised fee Structure for NSTI's (copy enclosed)
- For Govt ITI's and PVT ITI's, the fee structure will be communicated shortly.

7. Significant features of this course will be:

- A Stipend of Rs. 15,000/- p.m. will be provided by IBM for the duration of On-the-job-training (OJT) during last five months.
- A Scholarship/ stipend of Rs.3000/- p.m. may be provided by the IBM/Channel Partner based on performance, attendance and economic background of the students for the batches starting from the current session. The proposal is under consideration of IBM.
- IBM and its channel partners will provide the placement support to students post completion of the course. Placements will be based on their over-all performance/ merit during the course.
- IBM will also work on providing vertical mobility for the students passing the advanced diploma course to B. Voc. / similar courses being offered by its partner universities and
- IBM through its training partners will provide full-time faculty support at the selected locations during the initial takeoff period.
- IBM through its channel partners will provide support for Training of Trainers for each module would be 2 weeks incl. one-week face to face and one-week online

mode for all trainers involved in the course at 6 locations of NSTI's of Bangalore, Chennai, Mumbai, Hyderabad, Kolkata and Delhi NCR.


➤ Full time faculty will be supported for advanced modules by IBM through its training/industrial partners.

8. Infrastructure: Proper Computer Lab with basic infrastructure, preferably dedicated computer per student (20 -25 candidates) with internet facility of minimum 20 Mbps.

9. Faculty: At least 1 faculty (regular or contractual) who is willing to learn and teach the latest computer techniques/technology after being trained by IBM.

10. Training Facility: Projectors, White Boards, etc.


11. Further guidelines regarding the approval for affiliation in starting the course will be issued by CFI Section of DGT.


2. It is informed that the competent authority has approved following revised fee structure for the diploma courses with immediate effect:
