Subject: Clarification of letter - Removal of system of supernumerary

Sir/Madam,

In continuation of letter(s) of even no. dated 26th February, 2019 (copy enclosed). wherein recommendation of '**Recommendation Committee on Norms & Courses**' for removal of system of supernumerary and increase the unit size of trades under Craftsmen Training Scheme was communicated to all States/UT Directorate/department dealing Skill Development /Vocational Training.

In this regard, it is once again clarified that:

- (1). concept of admitting 30% supernumerary in the respective trade has been removed.
- (2). The unit size is increased from 10 to 12, 12 to 16, 16 to 20 and 20 to 24 for all trades excepting the following 13 high capital trades. Seats enhancement of said 13 trades would be as follows as earlier communicated vide letter no. MSDE-19/02/2018-CD, dated 26th February, 2019.

Above enhancement is done to accommodate 10% EWS quota by increasing seating capacity by up to 25%.

Number of hand tools would be increased as per the enhanced unit size. You are requested to take action at your end for implementation the same.

This will be effective from July/ August, 2019 admission.
