Subject: Decentralisation of Craftsmen Training Scheme (CTS) Admission – reg.

Sir / Madam,

With reference to the above cited subject, it has been decided to decentralise the Craftsmen Training Scheme (CTS) admission from the academic year 2022. It is further informed that Regional Directorates/HoDs will be responsible for smooth conduct of admission in NSTIs. All RDs will guide Principals of NSTIs and supervise the entire admission process to ensure transparency in work.

2. The CTS admission in NSTIs will be conducted **in line with ITI admission Timeline**. The details of Admission/Training schedule for the six months, one- and two-year trades of the Craftsmen Training Scheme (CTS) in National Skill Training Institutes (NSTIs) for the session 2022-23/24 is given below:

3. NSTIs will publish advertisement of CTS admission notice for the session 2022-23/24 in local newspapers (Hindi/English and Regional languages) for wide publicity. A copy of the advertisement should also be displayed on the Notice Board of Institute. NSTIs may also upload the admission notice on Institute's websites and other social media platforms. **CTS -2022 Prospectus** is attached herewith for more details.

4. **Central Reservation Policy** is followed in the admission process.

5. **Male candidates will also be given admission in NSTI (W)** against the vacant seats (except gender specific trades) after exhausting all women candidates in the list.

6. All NSTI are required to register/admit the candidates on NIMI portal through institute login id.

7. Admission in NSTIs may be allowed only 50% of affiliated trades in case of two-year courses, so that NSTIs can take admission every year.

8. In two-year trades, in same shift/unit, admission and uploading CANNOT be done in consecutive years.

9. Students with unique Mobile Number and email ID shall only be admitted and no change in mobile number and email ids allowed till students receive NTC.

10. Once student data viz. name, father name, mother name, DoB, Shift/unit correction each shall not be allowed.

11. NSTIs shall promote women candidates to take admissions in NSTIs to increase their participation in NSTIs admission.


12. For increasing the productivity and efficiency of the industry, availability of skilled manpower is a prerequisite, towards this, it is important to attract the most interested and keen talent for job role and train them accordingly. The NSTIs advised to take proactive steps for addressing information asymmetry in filling available trade (s) / seats through various measures such as the following:

- Advertise through local media, hoardings at prominent places, posters, and banner at secondary schools about the available training options available in each district.

- Encourage district education officer and principals of secondary schools to approach the students and parents for encouraging them seeking admission in NSTIs.
 - Provide appropriate counselling and guidance to the drop outs as well as prospective trainees about the career prospects after vocational training.
 - Co-ordinate with gram panchayats and local bodies for running a mobilisation campaign for admission.
 - Publicise through local channels, radios, print media and brochures.
13. District Skilling Committees may also be involved to take measures on broadening the prospective of NSTIs in their districts.
14. The RDSDEs are requested to sensitise the NSTIs for the admission process and take necessary steps for ensuring data veracity of admitted students.
15. All the concerned are requested to adhere to guidelines issued time to time by MHA and MoFHW with respect to COVID-19.
