Subject: Introduction of RPL variant course(s) to become Workshop Calculation & Science / Engineering Drawing Instructors.

Sir/Madam,


This is to inform that 8th meeting of Recommendation Committee of 'Affiliation' was held under the Chairmanship of DDG (C, P& Admn), DGT, MSDE on 30.09.2019 at Conference Room, DGT, Pusa, New Delhi wherein introduction of RPL variant course(s) in 'Workshop Calculation & Science' and 'Engineering Drawing' for existing instructors was discussed as additional agenda point no. 4 in the above meeting.

Committee approved to introduce RPL variants courses in Subjects 'Workshop Calculation & Science' and 'Engineering Drawing' for all CITS engineering trades as an alternative for one-year RoD&A CITS course. Accordingly:

1. The trade instructors who will be completing regular CITS of one year duration in engineering trades in the year 2020 and onwards will also be eligible for the instructor in WCS, ED or both.
2. RPL variant courses in 'Workshop Calculation & Science' (WCS) and 'Engineering Drawing'(ED) having duration of 80 hours each are being introduced in NSTIs/Govt. ITOTs from the year 2019-20. The detailed curricula of RPL variant WCS & ED is **annexed**.
3. The existing WCS and ED instructors who fulfil the RPL and instructor eligibility criteria of the concern subject have to undergo the said training and appear in AITT for RPL under CTS.
4. The existing trade instructors who do not have NCIC and fulfils the RPL eligibility criteria may also undergo the 80 Hr. training and appear AITT for RPL under CITS to become instructor for WCS/ED or both. By applying the for the same.
5. The instructors willing to become an instructor of WCS & ED have to pass both subject (WCS & ED) alongwith other papers as shown in below list. Otherwise he/she may choose either WCS OR ED and get training in 80 hours of desired subject.

ITI instructors (Trade/WCS/ED) do not have CITS but have 3 years or more experience and teaching	
Degree/Diploma	NTC/NAC in the Draughtsman (Mechanical)/Civil
Training Methodology (TM) + WCS OR ED or both as required.	Training Methodology (TM) + ED

6. The existing Non CITS instructors have to appear in AITT for RPL will have to attempt questions for WCS and ED from the common curricula of WCS and ED of different groups of CTS along with 80 hours crash courses.
7. The existing instructors having NTC/NAC in the Draughtsman (Mechanical)/Civil willing to become an instructor of ED, have to pass Training Methodology and Engineering Drawing subjects in AITT of RPL under CITS to get NCIC in ED.
8. The 10 day i.e. 80 hours training for the above WCS/ED should be conducted in NSTIs & Govt ITOTs or State Govt may conduct above training program in their good Govt ITIs on availability of suitable infrastructure and with prior permission from DGT.
9. All NSTIs and State Govt. ITOTs having ED hall and suitable infrastructure are advised to conduct the above training programme on ED & WCS for RPL aspirant with immediate effect and intimate the schedule to all State Govts/UTs.
10. One month POT (TM) training as decided earlier for RPL aspirant may also be conducted in NSTIs.
11. Exemption is allowed for RPL:
 - a) Who has passed ET Module in modular patter of CITS is allowed exemption of ED & WCS.
 - b) Who has passed POT Module is allowed exemption of TM.
12. TA/DA may be paid by the respective State Govt. for deputing the instructors for above training and AITT (RPL).
