The sanction relates to the Plan expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-II/2001 dt. 01.04.2011.
