- 3. The State of **Jharkhand** is required to utilise the aid as per the guidelines of the scheme and furuish physical and financial progress reports as per the formats prescribed in the Implementation manual.
- 4. The sanction relates to the Plan expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-II/2001 dt. 01.04.2011.
