Subject : Release of Grant-in-Aid to the State of **Bihar** for establishment of 1 ITI in Banka district under the Centrally Sponsored Scheme '**Skill Development in 47 Districts Affected by Left Wing Extremism**'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 396.90 Lakh (Rupees Three Crore Ninety Six Lakh and Ninety Thousand only)** towards 1<sup>st</sup> installment for Establishment of 1 ITI in Banka district in the State of **Bihar** under the Centrally Sponsored Scheme '**Skill Development in 47 Districts Affected by Left Wing Extremism**', as detailed below and subject to the conditions stated:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of Rs.396.90 Lakh (Rs. Three Crore Ninety Six Lakh and Ninety Thousand only) as grant-in-aid for creation of capital assets to the State Government of Bihar is subject to the following terms and conditions:

- i. The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- ii. Utilisation Certificate issued to DGT in form GFR-19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilisation.
- iii. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilisation certificate furnished by the State Government of Bihar.
- iv. The Sanction is valid upto one year from the date of issue.
- v. All the purchases will be made in accordance with the State Govt. norms.
- vi. Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The Bihar State is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.


5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24(35)/PF-II/2012 dated 29-08-2014.
6. The expenditure is debit-able to the Major Head 3601.06.101.36.04.35- Grants for creation of capital assets.
7. The amount of Rs.396.90 lakh (Rs. Three Crore Ninety Six Lakh and Ninety Thousand only) may be transferred to Government of Bihar through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) Dated 22-02-1977.
8. This is the 1<sup>st</sup> installment to the State of Bihar for establishment of new ITI at Banka District and UC will be furnished after receiving it from the State Government.
9. This issues in exercise of the delegated powers and in concurrence with the Finance-I Branch, Ministry of Skill Development & Entrepreneurship vide AS&FA Dy. No.235 dated 27.04.2017.
10. The entry has been made at Serial no.07/2017 at page 2 of Register maintained for Grant-in-aid.
