Sir,

I am directed to convey sanction of the President to incur expenditure not exceeding **Rs.871.60Lakh (Rupees Eight Crore Seventy One Lakh and Sixty Thousand only)** towards partial fulfillment of 1<sup>st</sup> installment for Establishment of total 06 ITIs, one (1) each in Jamui, Gaya, Aurangabad, Rohtas, Jehanabad and Arwal districts in the State of **Bihar** under the Centrally Sponsored Scheme '**Skill Development in 47 Districts Affected by Left Wing Extremism**', as detailed below and subject to the conditions stated:

2. The accounts of all grantee institutions or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provisions of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of Rs.871.60 Lakh (Rupees Eight Crore Seventy One Lakh and Sixty Thousand only) as grant-in-aid for creation of capital assets to the State Government of Bihar is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spent for Non-Recurring purposes only.
- Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation.
- The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilisation certificate furnished by the State Government of Bihar.
- The Sanction is valid upto one year from the date of issue.
- All the purchases will be made in accordance with the State Govt. norms.
- Utilization of fund will be assessed through monthly progress report, field visits, photograph/ videos etc.
- Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.


4. The Bihar State is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.
5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24 (35)/PF-II/2012 dated 29-08-2014.
6. The expenditure is debit-able to the Major Head 3601.06.796.18.07.35- Grants for creation of capital assets and Major Head 3601.06.101.36.07.35 - Grants for creation of capital assets as per para 1 above.
7. The amount of Rs.871.60 Lakh (Rupees Eight Crore Seventy One Lakh and Sixty Thousand) may be transferred to Government of Bihar through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.
8. This issues in exercise of the delegated powers and in concurrence with the Finance-I Branch, Ministry of Skill Development & Entrepreneurship vide AS&FA (L&E) FTS No.1133 dated 15.09.2020.

The matters relates to release of fund amounting to Rs.884.58 lakh for establishment of ITIs & SDCs under the Centrally sponsored Scheme "Skill Development in 47 Districts Affected by LWE" to the State of Bihar as partial fulfillment of 1<sup>st</sup> installment of ITIs & SDCs in districts (Jamui, Gaya, Aurangabad, Rohtas, Jehanabad, Arwal) covered in pre-revised scheme

2. After administrative approval, the proposal was forwarded to IFD for their concurrence on [para 8.b of NSP -192/corr.](#) ) of release of fund amounting to Rs.223.57 lakh as partial fulfillment of 1<sup>st</sup> installment of ITIs & SDCs in districts (Jamui, Gaya, Aurangabad, Rohtas, Jehanabad, Arwal) covered in pre-revised scheme. After examining the proposal, [IFD had made some queries](#). The queries made by IFD alongwith their responses are given below:

a) The UC doesn't match the figure as indicated by Programme division; and

response: Directorate of Labour and Training, Government of Bihar had submitted the utilisation certificate dated 02/07/2019 amounting to **Rs. 1504.14 lakh (p-408/corr)** out of released amount to the State i.e. Rs. 1932.19 lakh released for establishment of ITIs & SDCs in districts (Jamui, Gaya, Aurangabad, Rohtas, Jehanabad, Arwal) covered in pre-revised scheme "Skill Development in 47 Districts Affected by LWE". An amount of Rs. 428.04 lakh remained unspent. In the said UC, State submitted that the balance of Rs. 428.04 lakh will be adjusted towards the grants payable during the next year 2018-19.

Further, Government of Bihar has submitted the [UC dated 10/01/2019](#) stating that out of unspent balance i.e. Rs. 428.04 lakh, a sum of **Rs. 241.54 lakh** has been utilized for the purpose of ITIs and SDCs for which it was sanctioned.

It means Government of Bihar has submitted the UC amounting to a total of Rs.1504.14 lakh + Rs.241.54 lakh i.e. **Rs. 1745.68 lakh (90.34%)** out of released amount Rs.1932.19 lakh.

As State has submitted UC more than 90%, Bihar State is eligible for release of the balance amount of 1<sup>st</sup> installment i.e. **Rs.884.58 lakh** (Rs. 2816.77 lakh as admissible 1<sup>st</sup> installment – Rs. 1932.19 lakh as released fund) for establishment of ITIs and SDCs in covered districts under the pre-revised scheme.

b) UC is not original stamped by Competent Authority.

Response: The UC dated 10/01/2019 has been authenticate by Bihar Government by email dated 2<sup>nd</sup> September, 2020 and the same may be seen at [p- 558/corr.](#)

This is regarding to release **Rs 884.58 Lakh** as balance of 1<sup>st</sup> installment for establishment of 06 ITIs & 12 Skill Development Centers(SDC) at districts namely Jamui, Gaya, Aurangabad, Rohtas, Jehanabad and Arwal of State of Bihar under the Centrally sponsored Scheme "Skill Development in 47 Districts Affected by LWE"

2. The said scheme has been revised with an enhanced cost of Rs. 407.85 Cr after added 13 additional districts with the duration up to 2019-20. Subsequently, the Scheme has been extended up to March, 2021 or till the completion of recommendation report of 15th Finance Commission, whichever is earlier. The revised implementation plan is available at [pp.508-518/corr.](#) Under the pre-revised scheme, the cost for establishment of ITI was Rs 532.30 lakh/ITI (CS+SS). While revising the scheme during 2016, **the cost for establishment of ITIs was enhanced from Rs 532.30 lakh/ITI to Rs 734.60 lakh/ITI where construction work are yet to be started**. The cost for establishment of SDC was not changed (i.e. Rs 50.00 lakh). The same has been confirmed by SMD through telephonically conversation.

3. SMD vide e-mail dated 11.09.2020 has sent the details of ITIs and SDCs where construction work are yet to be started, while revising the scheme. The same is attached below. As per list provided by SMD, there were 6 ITIs and 12 SDCs at 6 districts namely Jamui, Gaya, Aurangabad, Rohtas, Jehanabad and Arwal of State of Bihar, where construction work was left to begin.

4. The SMD has submitted that earlier the State of Bihar had proposed for release of fund for all the 06 districts covered as stated above and amount of Rs 1932.19 lakh has been released for establishment of 06 ITIs and 12 SDCs. Further SMD has submitted that the State of Bihar has utilized Rs 1745.66 lakh (approx 90%) and forwarded the UCs for the same. The SMD has stated that out of admissible Central share i.e. Rs 2816.77 lakh (as per revised scheme), only Rs 1932.19 lakh has been released for establishment of 06 ITIs and 12 SDCs in 06 district as stated above. Hence, the SMD has proposed to release balance funds amounting to Rs 884.58 lakh for the said 06 districts of Bihar State under the Centrally sponsored Scheme "Skill Development in 47 Districts Affected by LWE".

5. Government of Bihar had submitted the utilisation certificate dated 02/07/2019 amounting to **Rs. 1504.14 lakh** ( [p-408/corr](#)) out of released amount to the State i.e. Rs. 1932.19 lakh released for establishment of ITIs & SDCs in districts (Jamui, Gaya, Aurangabad, Rohtas, Jehanabad, Arwal). 
