- 2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
- 3. The release of Rs. 412.92 Lakh (Rupees Four Crore Twelve Lakh and Ninety Two Thousand only) as grant-in-aid for establishment of 1 new ITI in Visakhapatnam district to the State Government of Andhra Pradesh is subject to the following terms and conditions:
 - The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
 - The sanction is valid for one year from the date of issue.
 - Subsequent release of fund will be made for establishment of 1 ITI after Utilisation Certificate (UC) of sufficient amount from State Government of above said amount along with State Share.
 - Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Standing Finance Committee (SFC).
- 4. The State of Andhra Pradesh is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation manual.

- 5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, O.M. No.24(35)/PF-II/2012 dated 29-08-2014.
- 6. The expenditure is debit-able to the Major Head 3601.06.101.36.04.35- Grant-in-aid for creation of capital assets.
- 7. The amount of Rs. 412.92 Lakh (Rupees Four Crore Twelve Lakh and Ninety Two Thousand only) may be transferred to Government of Andhra Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) Dated 22-02-1977.
- 8. This is the 1st installment to the State of Andhra Pradesh for establishment of ITI at Vishakhapatnam, UC will be made available when it will be due and submitted by the State.
- 9. This issues in exercise of the delegated powers and in consultation with the Integrated Finance Division, Ministry of Skill Development & Entrepreneurship vide AS&FA Dy. No.61 dated 28.08.2017.
- 10. The entry has been made at serial no. 9/2017 at page 02 of Register maintained for Grant-in-aid.
