All other terms and conditions for release of funds for the Project will remain unchanged.

 - The fund is being released as One Time Grant and shall be spent for Recurring purposes or as admissible as per SFC. The fund should be utilized with compliance of Section 'F' of MoA under the scheme.
 - Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure ii. statement may be furnished immediately after utilisation.
 - This is One Time Grant. No additional Grant will be released in future for above mentioned IMCs. iii.
 - The Sanction is valid till completion of the project period. iv.
 - All the procurements should be made through Government e marketplace(GeM) and in case of non availability of the item on GeM portal, may be procured in accordance with the State Govt. norms
 - Utilization of fund will be assessed through monthly progress report, field visits, photograph/ videos vi.
- Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the vii. admissibility as per SFC to be arranged by any other sources.
