Subject: Release of Grant-in-Aid to the State of **Bihar** for Skill Training in Six districts under the Centrally Sponsored Scheme 'Skill Development in 34 Districts Affected by Left Wing Extremism'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to Rs. 17.71 Lakh (Rupees Seventeen Lakh and Seventy One Thousand only) as 1st installment for Skill Training in six districts of Arwal (expect Stipend to the trainees), Aurangabad, Gaya, Rohtas, Jehanabad and Jamui in the State of Bihar under the Centrally Sponsored Scheme 'Skill Development in 34 Districts Affected by Left Wing Extremism', as detailed below and subject to the conditions stated:

- 2. First 30 trainees in the list proposed by the Bihar State are covered under the scheme in each district.
- 3. The above sanction is valid for Scheduled Caste trainees only for 25 trainees in Arwal, 26 trainees in Aurangabad, 5 trainees in Gaya, 21trainees in Rohtas, 27 trainees in Jehanabad and 27 trainees in Jamui.
- 4. Further the above sanction is subject to the following conditions:
  - The sanction is valid for one year from the date of issue.
  - For one District, 30 youth in Long Term Training of 24 months duration, 120 youth in Short Term Training of 03 months duration & 10 youth in Instructor Training of 12 months duration are supported.
  - Subsequent release of fund will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
  - Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC).
- 5. The State of Bihar is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation manual.

6. The sanction relates to the Plan expenditure and is in accordance with the aid appraised ( the appropriate appraisal forum Expenditure Finance Committee (EFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance-II Division OM No. 1(3)/PF-II/2001 dt. 01.04.2011.
