Subject : Release of Grant-in-Aid to the State of **Madhya Pradesh** for Establishment of One ITI in Mandla district under the Centrally Sponsored Scheme '**Skill Development in 48 Districts Affected by Left Wing Extremism**'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs. 1,37,74,000/- (Rupees One Crore Thirty-Seven Lakh and Seventy Four Thousand only)** as partial fulfillment of 1st installment towards Establishment of One ITI in one district (Mandla) in the State of **Madhya Pradesh** under the Centrally Sponsored Scheme '**Skill Development in 48 Districts Affected by Left Wing Extremism**', as detailed below and subject to the conditions stated:

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs. 1,37,74,000/- (Rupees One Crore Thirty-Seven Lakh and Seventy-Four Thousand only)** as grant-in-aid for establishment of ITI to the State Government of Madhya Pradesh is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
 - The sanction is valid upto till the completion of project period.
 - Subsequent release of fund, if applicable, will be made only after receipt of Utilisation Certificate (UC) from the State Government and sufficient utilisation of fund, subject to availability of fund.
 - Sanction of grant is strictly restricted to the admissibility as per the decisions arrived in the meeting of Expenditure Finance Committee (EFC)/Standing Finance Committee (SFC).
4. The State of **Madhya Pradesh** is required to utilise the aid as per the guidelines of the scheme and furnish physical and financial progress reports as per the formats prescribed in the Implementation manual.



5. The sanction is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, O.M. No.24 (35)/PF-II/2012 dated 05-08-2016.
6. The expenditure is debit-able to the Major Head 3601.06.101.36.07.35- Grant-in-aid for creation of capital assets.
7. The amount of Rs. 1,37,74,000/- (Rupees One Crore Thirty-Seven Lakh and Seventy Four Thousand only) may be transferred to Government of Madhya Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.
8. As per Department of Expenditure, Ministry of Finance's O.M. No F.No. 1(13)PFMS/FCD/2020 dated 23.03.2021, the State Government will transfer the Central Share received in its account in the RBI to the Concerned Single Nodal Agency's (SNA's) account within a period of 21 days of receipt. The bank details of SNA's are given below:

9. This is the 1st installment to the Madhya Pradesh for establishment of new ITI at Mandla District in the State, hence the question of UC does not arise.
