Subject: Release of Grant-in-Aid to the State of Meghalaya under the Centrally Sponsored Scheme 'Enhancing Skill Development infrastructure in NE States'.

Sir,
 I am directed to convey sanction of the President to incur expenditure not exceeding **Rs.421.64 Lakh (Rupees Four Crore Twenty One Lakh and Sixty Four Thousand only)** towards subsequent installment for Upgradation of 4 exiting ITI at Sohra, Resubelpara, Nongstoin and Nongpoh & Supplementing Deficient Infrastructure in 4 existing ITIs at Sohra, Resubelpara, Nongstoin and Nongpoh to the Society "Meghalaya State Council for Training in Vocational Trade" in the State of Meghalaya under the Scheme "Enhancing Skill Development infrastructure in NE States" as detailed below:-

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs.421.64 Lakh (Rupees Four Crore Twenty One Lakh and Sixty Four Thousand only)** as grant-in-aid for upgradation of existing ITIs to "Meghalaya State Council for Training in Vocational Trade" under the State Government of Meghalaya is subject to the following terms and conditions:

- viii. The fund sanctioned is of non -Recurring nature and shall be spent for non-Recurring purposes only.
- ix. Utilisation Certificate should be submitted online only through EAT module of PFMS, component wise, year wise expenditure statement may be furnished immediately after utilisation.
- x. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred, terms and conditions stated in Implementation Manual and utilisation certificate furnished by the State Government of Meghalaya.
- xi. The Sanction is valid upto one year from the date of issue.
- xii. All the purchases will be made in accordance with the State Govt. norms.
- xiii. Utilization of fund will be assessed by monthly progress report etc.
- xiv. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The "Meghalaya State Council for Training in Vocational Trade" is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OMNO.1(3)/PF-II/2001 dt1.4.2010.

6. The expenditure is debit-able to the Major Head-2230.03.102.15.12.35 - Grants in Aid for creation of capital assets.

7. Training Officer (Cash Section)/ Drawing and Disbursing Officer, DGT, Ministry of Skill Development and Entrepreneurship will draw the amount sanctioned vide para 1 above for Rs.421.64 Lakh and pay Rs.421.64 Lakh to the below mentioned society by transferring electronically to the bank account of the society. The details of the society are given below:


