Subject: Release of Grant-in-Aid to the State of Nagaland under the Centrally Sponsored Scheme 'Enhancing Skill Development infrastructure in NE States'.

Sir,

I am directed to convey sanction of the President to incur an expenditure not exceeding to **Rs.442.80 Lakh (Rupees Four Crore Forty Two Lakh and Eighty Thousand only)** towards 2<sup>nd</sup> installment for establishment of 2 new ITIs at Kiphire and Longleng Districts in the State of Nagaland under the Scheme "Enhancing Skill Development infrastructure in NE States" as detailed below:-

2. The accounts of all grantee institutions or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
3. The release of **Rs.442.80 Lakh (Rupees Four Crore Forty Two Lakh and Eighty Thousand only)** as grant-in-aid for creation of capital assets for 2<sup>nd</sup> installment for establishment of 2 new ITIs at Kiphire and Longleng districts to State of Nagaland is subject to the following terms and conditions:
  - i. The fund sanctioned is of Non -Recurring nature and shall be spent for Non - Recurring purposes only.
  - ii. Utilisation Certificate should be submitted online only through EAT module of PFMS, component wise, year wise expenditure statement may be furnished immediately after utilisation.
  - iii. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred, terms and conditions stated in Implementation Manual and utilisation certificate furnished by the State Government of Nagaland.
  - iv. The Sanction is valid during this Financial Year i.e. 2021-22.
  - v. All the purchases will be made in accordance with the State Govt. norms.
  - vi. Utilization of fund will be assessed by monthly progress report etc.
  - vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.
4. The State of Nagaland is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.
5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dt1.4.2010.



6. The expenditure is debit-able to the MH 3601.06.101.36.07.35- Grants for creation of capital assets as per para-1 above.
7. The amount of Rs. 442.80 lakh (Rs. Four Crore Forty Two lakh and Eighty Thousand only) may be transferred to the Government of Nagaland through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.
8. As per Department of Expenditure, Ministry of Finance's O.M. No F.No. 1(13)PFMS/FCD/2020 dated 23.03.2021, the State Government will transfer the Central Share received in its account in the RBI to the Concerned Single Nodal Agency's (SNA's) account within a period of 21 days of receipt. The bank details of SNA's is given below:

11. The entry has been made at Serial no 03/2021-22 at page 186 of Register maintained for Grant-in-aid.


