Subject: Release of Grant-in-Aid to the State of **Bihar** for 5 Institute Management Committees in 5 ITIs in 5 districts under the Centrally Sponsored Scheme '**Skill Development in 48 Districts Affected by Left Wing Extremism**'.

Sir,

I am directed to convey sanction of the President to incur expenditure not exceeding **Rs.5,00,00,000.00 (Rupees Five crore only)** towards One Time Grant for 5 Institute Management Committees (IMCs) @ Rs. one Crore per IMC each in Jamui, Aurangabad, Rohtas, Jehanabad and Arwal districts in the State of **Bihar** under the Centrally Sponsored Scheme '**Skill Development in 48 Districts Affected by Left Wing Extremism**', as detailed below and subject to the conditions stated:

2. The accounts of all grantee institutions or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provisions of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs.5,00,00,000.00 (Rupees Five crore only)** as One Time Grant for 5 Institute Management Committees (IMCs) in Jamui, Aurangabad, Rohtas, Jehanabad and Arwal districts in the State of **Bihar** is subject to the following terms and conditions:

- i. The fund is being released as One Time Grant and shall be spent for Recurring purposes or as admissible as per SFC. The fund should be utilized with compliance of Section 'F' of MoA under the scheme.
- ii. Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation.
- iii. This is One Time Grant. No additional Grant will be released in future for above mentioned IMCs.
- iv. The Sanction is valid till completion of the project period.
- v. All the procurements should be made through Government e marketplace(GeM) and in case of non availability of the item on GeM portal , may be procured in accordance with the State Govt. norms of procurement.
- vi. Utilization of fund will be assessed through monthly progress report, field visits, photograph/ videos etc.

vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The Bihar State is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24 (35)/PF-II/2012 dated 29-08-2014.

6. The expenditure is debit-able to the Major Head 3601.06.796.18.07.31- Grants-in-Aid General, 3601.06.789.19.07.31- Grants-in-Aid General and Major Head 3601.06.101.36.07.31 – Grants-in-Aid General as per para 1 above.

7. The amount of **Rs.5,00,00,000.00 (Rupees Five crore only)** may be transferred to Government of Bihar through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.


