Subject: Release of Grant-in-Aid to the State of Assam under the Centrally Sponsored Scheme 'Enhancing Skill Development infrastructure in NE States and Sikkim'.

Sir,

I am directed to convey sanction of the President of India to incur an expenditure not exceeding to **Rs.5,44,75,000.00 (Rupees Five crore forty-four lakh and seventy-five thousand only)** towards subsequent installment for establishment of new ITI at Nalbari and Jorhat in the State of Assam under the Sub-Scheme "Enhancing Skill Development infrastructure in NE States and Sikkim" of Umbrella Scheme "Strengthening of Institutional Infrastructure and Training (3640)" as detailed below:-

2. The accounts of all grantee institution or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.

3. The release of **Rs.5,44,75,000.00 (Rupees Five crore forty-four lakh and seventy-five thousand only)** grant-in-aid for creation of capital assets to the State Government of Assam is subject to the following terms and conditions:

- The fund sanctioned is of Non-Recurring nature and shall be spend for Non-Recurring purposes only.
- Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation by the State Government of Assam.
- The Sanction is valid till completion of the project period.
- All the procurements should be made through Government e marketplace( GeM) and in case of non-availability of the item on GeM portal , may be procured in accordance with the State Govt. norms of procurement.
- Utilization of fund will be assessed by monthly progress report, field visits, photograph/ videos etc.
- Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.

4. The State of Assam is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, Plan Finance- II Division OM NO.1(3)/PF-II/2001 dt1.4.2010.

6. The expenditure is debit-able to the Major Head 3601.06.789.85.00.35 - Grants for creation of capital assets and Major Head 3601.06.796.93.00.35- Grants for creation of capital assets as per para 1 above.

7. The amount of **Rs.5,44,75,000.00 (Rupees Five crore forty-four lakh and seventy-five thousand only)** be transferred to Government of Assam through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.

8. As per Department of Expenditure, Ministry of Finance's O.M. No F.No. 1(13)PFMS/FCD/2020 dated 23.03.2021, the State Government will transfer the Central Share received in its account in the RBI to the Concerned Single Nodal Agency's (SNA's) account within a period of 21 days of receipt. The bank details of SNA's are given below:




