I am directed to convey sanction of the President to incur expenditure not exceeding Rs.113.62 Lakh (Rupees One Crore Thirteen Lakh and Sixty Two Thousand only) towards 2nd installment for Establishment of 01 ITI and 02 SDCs in Khammam district in the State of Telangana under the Centrally Sponsored Scheme 'Skill Development in 47 Districts Affected by Left Wing Extremism', as detailed below and subject to the conditions stated:

- 2. The accounts of all grantee institutions or organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provisions of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so. All other terms and conditions for release of funds for the Project will remain unchanged.
- 3. The release of Rs.113.62 Lakh (Rupees One Crore Thirteen Lakh and Sixty Two Thousand only) as grant-in-aid for creation of capital assets to the State Government of Telangana is subject to the following terms and conditions:
 - i. The fund sanctioned is of Non-Recurring nature and shall be spent for Non-Recurring purposes only.
 - ii. Utilisation Certificate issued to DGT in form GFR-12C and component wise, year wise expenditure statement may be furnished immediately after utilisation.
 - iii. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilisation certificate furnished by the State Government of Telangana.
 - iv. The Sanction is valid upto one year from the date of issue.
 - v. All the purchases will be made in accordance with the State Govt. norms.
 - vi. Utilization of fund will be assessed through monthly progress report, field visits, photograph/ videos etc.
- vii. Sanction of grant is strictly restricted to the admissibility as per the SFC. Any expenditure beyond the admissibility as per SFC to be arranged by any other sources.
- 4. The Telangana State is required to utilize the aid as per the guidelines of the Scheme and furnish physical & financial progress report as per the format prescribed in Implementation Manual of the Scheme.

- 5. The sanction relates to Plan Expenditure and is in accordance with the aid appraised by the appropriate appraisal forum Standing Finance Committee (SFC) and approved by the appropriate approval authority in terms of Ministry of Finance, Department of Expenditure, No.24 (35)/PF-II/2012 dated 29-08-2014.
- 6. The expenditure is debit-able to the Major Head 3601.06.101.36.07.35 Grants for creation of capital assets.
- 7. The amount of Rs.113.62 Lakh (Rupees One Crore Thirteen Lakh and Sixty Two Thousand only) may be transferred to Government of Telangana through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) Dated 22-02-1977.
- 8. Certified that no utilisation certificate is pending in respect of the State mentioned in the sanction order as per requirement.
- 9. UC as per form 12-C of GFR 2017 submitted by the State mentioned in the sanction order is enclosed.
